The Fox Cities Exhibition Center, which is being built in downtown Appleton, will be a stateof-the-art facility for conventions, trade shows, banquets, meetings, and entertainment. The multi-purpose convention center was designed to be aesthetically attractive and flexible for a variety of events. The facility will have 30,000 square feet of indoor exhibition space and 17,000 square feet of outdoor plaza space. Its most unique architectural statement will be an 82-foot spire reminiscent of the year 1882, when the city of Appleton's first hydroelectric power plant began operation on the Fox River. VerHalen's field crew has been working on exterior and interior framing, hanging drywall, acoustical ceilings and wall panels with wrapped fabric.

Cerebral Palsy Inc., which opened in 1954, continues to provide health care and other social services to more than

2,000 children and adults in Northeastern Wisconsin. The facility is being renovated and expanded nearly 21,400 square feet in order to better help the needs of Cerebral Palsy's growing programs. The expansion, which will increase the square footage at the center by almost 50 percent, has been successfully obtained through both private and public campaigns. Some of additions include large therapy gyms, additional space for childcare, and family-friendly locker rooms at the Aquatic Center. Our field crew has been spending their time and efforts with exterior and interior framing and hanging drywall.


